Chairman Scharmann asked if there was any public comment but there was none.

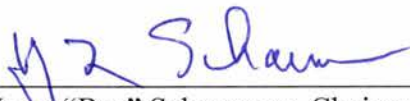

The meeting was adjourned at 9:04 AM.



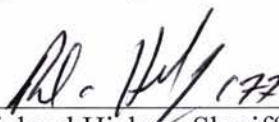
