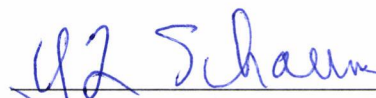

The meeting was adjourned at 9:24 AM.



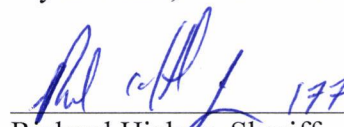
